PHCY306 - Social, Administrative & Legal Aspects of Pharmacy Practice, University of Nizwa (*Assistant Professor*). This course provides an understanding of social, behavioral, managerial, and legal aspects, with an emphasis on their implications for patient care. It also equips the students to develop leadership, decision-making, and management roles in providing pharmaceutical care through an evidence-based, legal, and ethical practice of pharmacy. The course also focuses on drug regulatory aspects and approvals.. Summer & Fall 2025

PHCY412L - Pharmacy Skills Lab-3, University of Nizwa (*Assistant Professor*). This course aims to enhance the student's skills to deliver patient-centered services as a pharmacist in a healthcare setting. The students must integrate their knowledge, skills, and values in attaining the course objectives. The course discusses and reviews medication order preparation, identifies

drug-related problems and makes suitable recommendations, communicates with healthcare professionals, documents interventions, and counsels/educates patients, Fall 2025

PHAR 6758 - Pulmonary Pharmacotherapy, University of Minnesota (*Teaching Assitant*). This course provides students with the requisite pathophysiology and pharmacotherapeutic knowledge to care for patients with common pulmonary diseases, Spring 2019

PHAR 6971 - Geriatric Pharmacotherapy, University of Minnesota (*Teaching Assitant*). This course focuses on pharmacokinetic/pharmacodynamic changes and their implications in elders. It examines the effects of drug-drug and drug-disease interactions, as well as drug adherence barriers, to provide optimum pharmacotherapy to elderly persons, Spring 2019

PHAR 6772 - Topics in Pharmacotherapy, University of Minnesota (*Teaching Assitant*). This course is designed to provide students with the pharmacologic, pharmacotherapeutic, and pharmaceuticals knowledge they need to understand therapies for dermatologic, gastrointestinal, and genitourinary conditions, and arthritis and gout. It is designed to prepare future generalist pharmacists to be knowledgeable about common conditions of aforementioned topics and appropriate pharmacotherapy options for treatment, Fall 2018

PHAR 6701 - CoP Community Outreach, University of Minnesota (*Teaching Assitant*). This course provides students with hands-on learning experiences in community and clinic-based environments, where they participate in interprofessional models of patient care alongside other healthcare professionals, Fall 2018
